Dear Partners and Members,

It has been almost seven years since the international "4 per 1000" Initiative was launched during the UNFCCC COP21 in Paris by the then French Minister of Agriculture, Stéphane LE FOLL, now Mayor of Le Mans and President of the Initiative. These seven years have been rich in achievements, the elaboration of strategic documents (2050 Strategic Plan and Implementation Plan), scientific documents (repository of indicators and criteria for the evaluation of projects, guidelines for an international research and scientific cooperation programme, scientific or opinion articles, etc.), international meetings ("4 per 1000" day each year during the UNFCCC COP, regional meetings, online workshops and working groups, etc.), provision of collaboration and networking tools (collaborative platform, virtual fair, Community of Practice, etc.), communication to the general public and the network, website ([The International "4 per 1000" Initiative - Soils for food security and climate \(4p1000.org\)](https://4p1000.org)), social networks, book, newsletter in three languages, weekly press review, etc.), not to mention the participation of the President and Vice-Presidents, members of the Scientific and Technical Committee and the Executive Secretariat in countless conferences, workshops and meetings to raise the profile of the Initiative and advance its objectives of sequestering carbon in soils through agroecology to combat climate change, adapt agriculture and forestry to climate change and improve food security.



For the past seven years, the Executive Secretariat, initially composed of yours truly (made available by the French Ministry of Agriculture), has grown thanks to the support of the INIA and then the Spanish Ministry of Agriculture, as well as the German BMEL and the French CIRAD, to reach a total of 4.8 FTEs, to which should be added 0.6 FTEs of a position financed by the Initiative's budget, i.e. a total of 5.4 FTEs to date. As far as financial support is concerned, year after year, the annual budget available is around €400,000, thanks to various public and private contributions, i.e. around 40% of the budget approved by the Consortium of Members and considered essential for the work of the Executive Secretariat at the service of the Initiative's network.

As I said in Glasgow last year in November during the Consortium meeting, this fragile situation, which is extremely demanding and exhausting for the entire Executive Secretariat team who have to cope with increasing expectations and demands, cannot last forever. It is imperative that the Initiative has broad support in terms of human and financial resources in order to fulfil its role. This is the purpose of this special newsletter. Because the adoption of the Strategy 2050 Implementation Plan, this summer, means that we now need to find new funding, not only to support the Executive Secretariat, but also to support the Alliances and Partnerships that will work to implement each activity designed to help achieve the 24 Objectives of the Strategic Plan. This is about scaling up, commitment and solidarity to achieve the essential for the health of the world's soils.

This year we will be at COP 27 again, organising the 6th "4 per 1000" Day. It will be hard to do, but we hope it will not be the last time.

We know that we can count on you, and that you will respond to this call. Discover in this newsletter all the ways you can support the Initiative.

Take care of yourself, your loved ones and your soils for our children.

Why should you support the international "4 per 1000" Initiative?

For many years, we have managed to run the Initiative as best we could with the budget we have each year. The available budget generally does not represent more than 40% of the budget validated annually by the Consortium of members, which does not prevent us from acting, but greatly limits our possibilities to do more, to do better in the service of the "4 per 1000" community and the great causes we defend. From 2023, the situation will change dramatically.

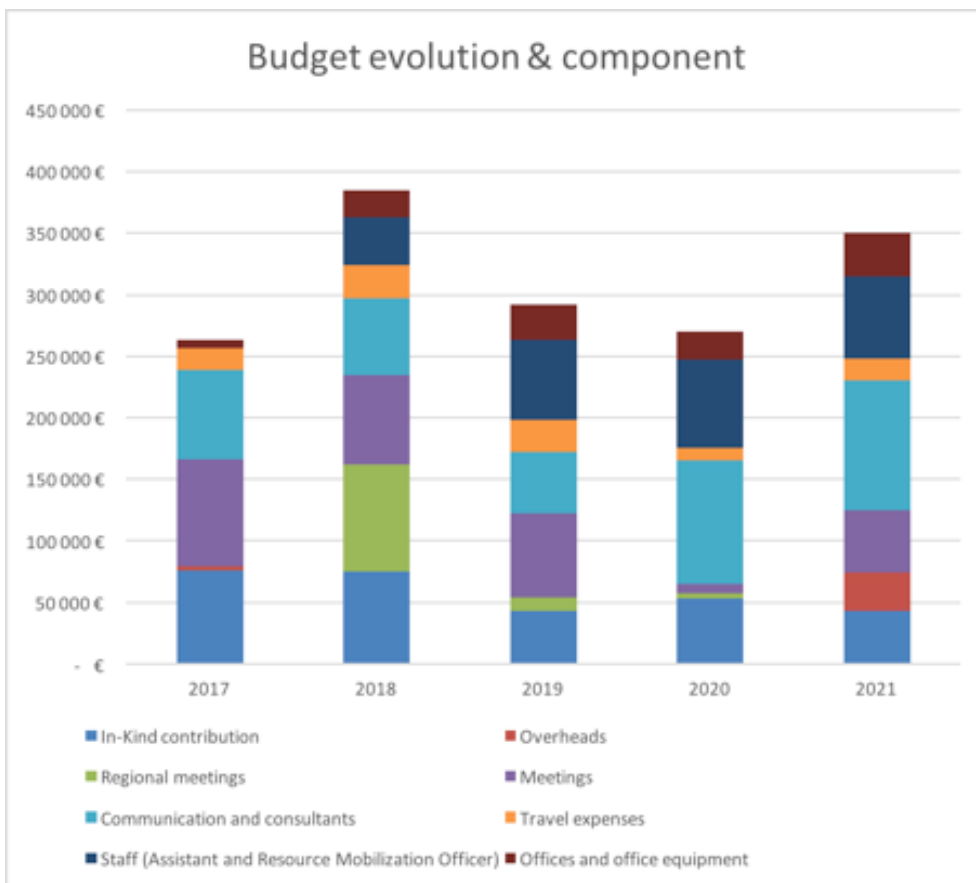
At the modest level of the Initiative, we have taken a major step forward in 2022, by building on the foundations of the 2050 Strategic Plan validated in 2020, a very ambitious Implementation Plan, articulated in 148 actions in the service of our 24 objectives. We have given substance to the Operational Framework of the Initiative, revitalized the Task Forces launched at the end of 2020 to build the Implementation Plan, with the task, now, of moving to action, and finally elaborated the Strategic Implementation Cycle to facilitate the concretization of actions under the impulse of the Task Forces.

Everything is in order for the design of projects, their implementation thanks to adequate funding and strong partnerships and alliances. All that is needed now is the will: the political will to support these projects, the will to support their implementation, and the will to act by being part of these partnerships and coalitions. All of this now depends on our individual and collective goodwill to translate commitments and words into action on the ground.

This is where things change, because if we remain at our current modest level, the means will be lacking to pursue the indispensable activities, the fundamental tasks, which make the initiative exist, live, develop its influence and advance its objectives. Not only will we not be able to carry out the "core facilities" entrusted to us by the operational framework, but we will also not be able to accompany and support the "global facilities" of the same framework, which are just as important. They will require special funding on a different scale to be implemented on the ground by the alliances and coalitions of partners and friends of the "4 per 1000" Initiative with the support of the Task Forces.

We have now passed the time for reflection, the development of strategies and framework documents, and we need to find support on a new scale to contribute to the transition to action and to accompany those who want to act as quickly as possible in a concrete way.

This call for support could well be the last one and everything we have built together would be in vain. We cannot resign ourselves to this because it would be an immense waste and an inexcusable renunciation. This is why we are calling on all good wills and all support from the most modest to the most important. There is no small support, there are only supports, and they are all welcome.

The role of the international "4 per 1000" Initiative

Launched at UNFCCC CoP 21 in December 2015, the international "4 per 1000 Initiative: Soils for Food Security and Climate" aims to show that agriculture, and in particular agricultural soils, can provide concrete solutions to the challenge of climate change while at the same time meeting the challenge of food security by implementing agricultural practices adapted to local conditions: agroecology, agroforestry, regenerative agriculture, conservation agriculture, landscape management, etc.

The international "4 per 1000" Initiative promotes the natural sequestration of organic carbon in soils and brings the vision of healthy, carbon-rich soils to fight climate change and eradicate world hunger.

Based on solid scientific documentation, the international "4 per 1000" Initiative encourages all voluntary actors around the world to engage in a transition towards a regenerative, productive, highly resilient agriculture, based on appropriate management of land and soil, which creates jobs and incomes and thus leads to sustainable development.

By uniting all its partners around soil health and the need to make the transition to sustainable agriculture, the international "4 per 1000" Initiative is promoting this change on a global scale.

The role of the Executive Secretariat team

The Executive Secretariat is the executive body of the international "4 per 1000" Initiative. Its mission is to provide support to the three governance bodies (Partners Forum, Consortium of Members as well as the Bureau, and Scientific and Technical Committee) and to coordinate and implement the annual roadmap of the Initiative and the Strategic Plan, particularly through the organization of statutory meetings and the management of common tools including the collaborative platform.

Hosted by the Alliance Bioversity International-CIAT, an International Organization with headquarters in Montpellier (France), the Executive Secretariat is made up of a small team managed by Dr. Paul Luu, Executive Secretary of the "4 per 1000" Initiative since September 1, 2016.

The human and financial resources allowing the operation of the Initiative, including the Executive Secretariat, are provided on a voluntary basis by some Members and Partners of the Initiative.

Dr. Paul LUU, Executive Secretary of the "4 per 1000" Initiative, is in charge of the coordination of the Executive Secretariat team, the mobilization of resources, implementation of the roadmap and organization of the statutory meetings of all bodies of the Initiative.

Since September 2016, Paul LUU has been seconded by the French Ministry of Agriculture and Food as Executive Secretary of the international Initiative "4 per 1000: Soils for Food Security and Climate", launched at the COP 21 in Paris.

Dr. Paloma MELGAREJO-NARDIZ, Sciences Officer in charge of the link with the international research and scientific cooperation program and of the Secretariat of the Scientific and Technical Committee of the Initiative. Paloma was based in Paris (France) in the offices of INRAE until July 2022, now she is in Madrid. Dr Paloma MELGAREJO is a research professor at the Spanish Ministry of Agriculture, Fisheries and Food (MAPA). **Dr MELGAREJO is provided to the Initiative by the Spanish Government, through the Spanish Ministry of Agriculture, Fisheries and Food.**



Ms Claudia SCHEPP is supporting the "4 per 1000" Initiative in her function as desk officer at the German Federal Office for Agriculture and Food (BLE).



Mr. Samuel OTTNAD has been member of the international climate team of **Division 334 of the Federal Office for Agriculture and Food (BLE)** since July 2021, which supports the Executive Secretariat of the "4 per 1000" Initiative.



Ms Julia KLEMME works at the German Federal Office for Agriculture and Food (BLE). Ms SCHEPP, Ms KLEMME and Mr OTTNAD are based in Bonn (Germany).

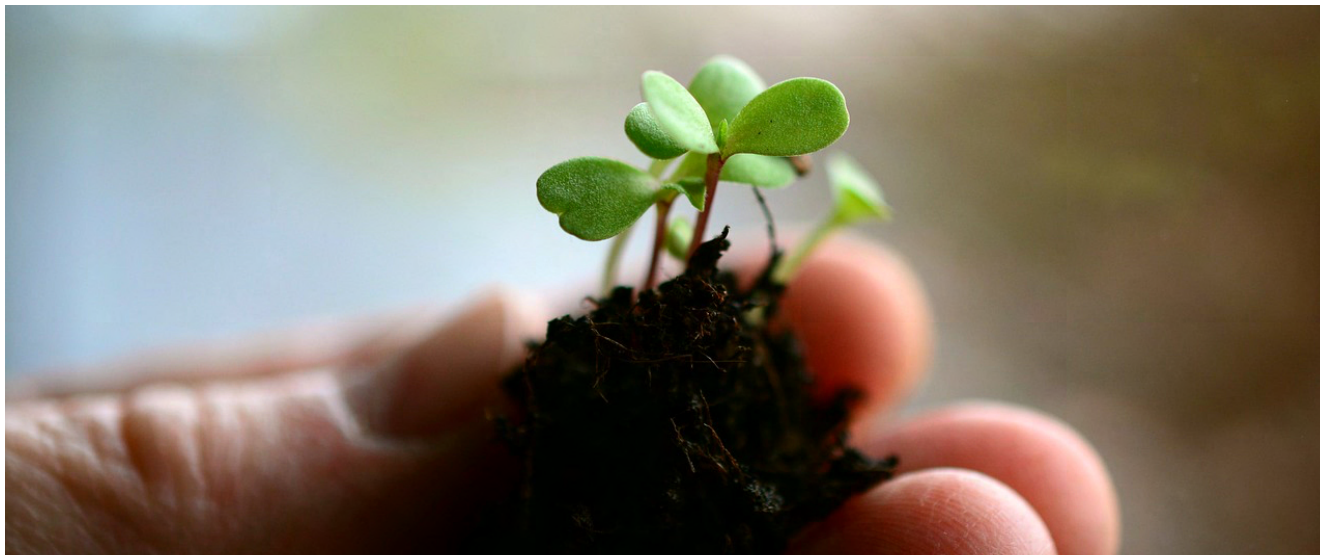

The Scientific and Technical Committee of the international "4 per 1000" Initiative

The international "4 per 1000" Initiative has set up a strong Scientific and Technical Committee to guide its actions on a scientific level with 14 renowned experts.

The Scientific and Technical Committee (STC) is the scientific body of the "4 per 1000" Initiative. The STC was installed on November 17, 2016 during COP22 in Marrakech.

It is **multidisciplinary group, with a balanced composition in terms of geographical origin and gender**, made up of **14 high-level scientists of international renown**, nominated by the Consortium of Members on the proposal of the Executive Secretariat after voluntary application by each scientist. Since 2017, the Chair of ITPS (Intergovernmental Technical Panel on Soils attached to the Global Soil Partnership hosted by FAO), is a permanent invitee of the STC.

The STC meets twice per year in face-to-face meetings or virtually to:

1. propose a set of benchmarks for the evaluation of projects and actions based on the principles and objectives of the Initiative, as well as on the Sustainable Development Goals,
2. formulate proposals for the guidelines of the international program for scientific research and cooperation and for any cross-cutting issue,
3. define the vision and mission of the Initiative,
4. provide scientific and technical advice on the implementation, monitoring, reporting and verification of field projects, actions and programs,
5. assess projects submitted to the "4 per 1000" Initiative,
6. discuss issues related to the implementation and the outreach of the Initiative,
7. provide advice for the participation of the Initiative in the high-level political process and the establishment of its relation to other international bodies and
8. elaborate a roadmap.

Up to June of 2022, the STC has had 13 meetings since its launch. New meeting will be hold in Sharm el Sheik, in the framework of the COP 27.

Funded by the Spanish government, Paloma MELGAREJO is one of the members of the Executive Secretariat. Paloma supports, animates and organizes the work of the STC.



The main actions of the Scientific and Technical Committee of the international "4 per 1000 » Initiative

To address the knowledge gaps to best enhance global SOC stocks, while also ensuring food security and climate change adaptation, the STC proposed [an international research and scientific cooperative program](#).

[An ensemble of criteria, indicators, methods and units of measurement](#), has been developed by the STC **to provide guidance to project holders and to provide formative assessment of projects**.

Every year, the "4 per 1000" Initiative launches a **call for formative assessment of projects**. After completion of the assessment process, the project holders receive a report including the assessment result and recommendations from the STC. A short description of the projects that are in conformity with the aims of the "4 per 1000" Initiative is published on the website of the initiative and receives a final report recommending it for funding from funders compatible with the goal of the Initiative. Since the year 2019, four calls have been launched. Forty two projects have been submitted from all the continents which shows the interest of the different actors in implementing the objectives of the Initiative on the ground. After evaluation for the STC, 13 were considered in line with the objectives of the Initiative "4 per 1000" (the 4th call has not been not evaluated yet). More information [here](#).

The STC is editing a special issue in the international journal "Regional Environmental Change" with the title "Sustainable management practices to increase soil carbon sequestration: what are their contribution to climate change mitigation, adaptation and food security in different ecosystems and regions of the world".

The STC members have presented several papers in regional or international conferences and has contributed to and co-organized several workshops and events around the world.

The STC made an analysis of the Intentionally Determined Contributions (INDCs) and NDCs in order to gather information on the importance of SOC in the countries' NDCs in the UNFCCC negotiations. [The results were published in and Info Note \(CCAFS Info Note](#). Wageningen, Netherlands: CGIAR Research Program on Climate Change, Agriculture and Food Security - CCAFS) and a paper in *Climate Policy*: "[Countries' commitments to soil organic carbon in Nationally Determined Contributions](#)".

On the Koronivia Joint Work on Agriculture (KJWA) the STC, together with a group of research and higher education institutions and programs, submitted their science-based views, to for the workshops taking place at **SBSTA/SBI 5&6 on topic 2(c), 2(d), 2(e) and 2(f)**.

The STC has contributed to writing and reviewing several GSP documents such as the Technical Manual on SOC Management, the "Protocol for Measurement, Reporting, Verification and Monitoring to assess soil organic carbon sequestration and greenhouse emissions in agricultural landscapes (GSOC-MRW), the Carbon Sequestration potential map and the GSOCseq Technical report.

On June 15th 2020, the "**4 per 1000**" **Strategic Plan** for the next 30 years was endorsed by the Consortium. The STC contributed to the development since the start of the process. For developing a plan of actions to implement the strategic Plan the STC members contribute to different objectives and task forces.

The Scientific and Technical Committee provides the scientific basis for the international "4 per 1000" Initiative, so it is very important to support it, for example by hosting and taking care of the logistics of one of its meetings.



"4 per 1000 Initiative" Day

The 6th international "4 per 1000" Initiative Day will be held face-to-face and online on November 16, 2022 in Sharm El-Sheikh, Egypt, on the sidelines of COP27. The theme for this day is "Healthy Soils for a Healthy Planet".

This event is divided into 2 parts:

- The Forum of Partners meeting is open to all, and will take place from 9:00 am to 2:00 pm (local time). The Forum will start with a high-level segment, then the floor will be given to the different constituencies of the Forum to express themselves on how to achieve the objective "Healthy Soils for a Healthy Planet".
- The Consortium of Members, reserved for Members of the Initiative, will be held from 3:30 p.m. to 6 p.m. (local time).
